

# TRAFFIC ADVISORY: Overnight Closure of Eastbound and Westbound I-80 between San Pablo Avenue and San Pablo Dam Road Starting Saturday, June 18, 2016 at 11:00 p.m.

**San Pablo, CA** – A full overnight closure of eastbound and westbound Interstate 80 between San Pablo Avenue and San Pablo Dam Road is scheduled for Saturday, June 18th from 11:00 p.m. until 7:00 a.m. on Sunday, June 19th.

**Impacts to local and regional traffic are expected. Motorists are advised to plan ahead and allow extra drive time.**

The temporary overnight closure is a continuation of the I-80/San Pablo Dam Road Interchange Reconstruction Project led by the Contra Costa Transportation Authority (CCTA) in partnership with the California Department of Transportation (Caltrans), the Metropolitan Transportation Commission (MTC), and the City of San Pablo.

The first phase of the project will relocate the El Portal Drive onramp to westbound I-80 to the north, extend the auxiliary lane along westbound I-80 between the San Pablo Dam Road off-ramp and the El Portal Drive on-ramp, and reconstruct the Riverside Avenue pedestrian overcrossing.

These overnight closures are essential to motorist and public safety. Crews will adjust and align falsework (temporary support structures) recently constructed across I-80 for a new pedestrian overcrossing at Riverside Avenue. The new structure will replace the current overcrossing. When completed, students, parents, and community members will have safer access to Riverside Elementary School in San Pablo, as the new structure will eliminate the need to cross busy Amador Street.

## Detour Routes

Local traffic will be detoured to San Pablo Avenue. Regional traffic is advised to use State Route 4 or Interstate 780 to Interstate 680 and State Route 24 to detour around the closure area. See detour maps at <http://ccta.net/sanpablodamroad>.

## About the I-80/San Pablo Dam Road Interchange Reconstruction

The Interstate 80/San Pablo Dam Road interchange provides access between residential areas north and east of the interchange and Bay Area employment centers. The first phase of the project will relocate the El Portal Drive on-ramp to westbound I-80 to the north, extend the auxiliary lane along westbound I-80 between the San Pablo Dam Road off-ramp and the El Portal Drive on-ramp, and reconstruct the Riverside Avenue pedestrian overcrossing. The second phase of the project, which is currently under development, includes replacing the existing San Pablo Dam Road bridge in phases that will keep traffic flowing, by building one side of the bridge, moving traffic to it, demolishing the old bridge, and then building the other side. The final product will be a safer and more accessible interchange for years to come, not just for drivers but for pedestrians and bicyclists as well.

Benefits of the overall project include improved traffic operations, reduced traffic congestion, efficient and safe bicycle/pedestrian access at the interchange, and the accommodation of future traffic volumes on San Pablo Dam Road.
