# More PRESTO Autonomous Vehicle Pilots Rolling Out Soon

We've been busy ramping up our Automated Driving Systems (ADS) project and are excited to share the latest details of two new pilots! These will feature autonomous vehicles in northern Martinez and at the active senior adult community at Rossmoor in Walnut Creek.

In early 2024, CCTA will launch PRESTO Martinez in partnership with County Connection and May Mobility. The pilot will provide free microtransit service to help patients and their families get to their doctor's offices on time, to help reduce missed medical appointments. The pilot could potentially expand to allow residents to use PRESTO as a transportation option in downtown Martinez during off-peak hours, when the medical

centers aren't as busy. The service will operate up to six autonomous vehicles, which will each have a specially trained attendant onboard.

CCTA is also excited to launch PRESTO Rossmoor in partnership with Beep. The pilot will feature two PRESTO shuttles—like those at Bishop Ranch—that will travel on a one-mile loop at the site and will also have trained attendants on board for every ride. The shuttles hold the promise of substantially enhancing the quality of life for Rossmoor residents, providing newfound accessibility to daily activities such as attending fitness classes and engaging in social events. The eight-month pilot is set to begin in spring 2024.

# **Project Updates**





#### **MOBILITY AS A SERVICE**

CCTA's planned carshare pilot is set to kick off in mid-2024, alongside the Mobility on Demand (MoD) pilot app that will be used to access the service. The pilot will make it possible for travelers in Pleasant Hill, Walnut Creek, San Ramon, and Danville to easily access short-term rental cars for local trips.



#### **AUTOMATED DRIVING SYSTEMS**

The vehicles for our two upcoming pilots (see cover story of this issue) will be arriving soon and will be stylishly wrapped, like our chic PRESTO Bishop Ranch shuttles. Test runs on the planned routes will begin in the next few months, allowing us to monitor operations and calibrate the vehicles ahead of the launch. #### SHARED MOBILITY HUBS

We recently won a grant to build an initial phase of a shared mobility hub at the Martinez Amtrak Station. This marks our second shared mobility hub in development, following the hub at Bollinger Canyon Road in San Ramon. We'll soon be hiring a team of consultants to help design the hubs. #### **PART-TIME TRANSIT LANES**

Exciting news! We're going to start testing part-time transit lanes at the GoMentum Station in Concord in the new year and are currently searching for a team of consultants who can help with testing and training. This stage is crucial to understanding how these lanes will function in heavy traffic and for training bus operators to use these lanes properly and safely.



#### **ADVANCED TECHNOLOGIES**

In September, our staff and consultants participated in an onsite review and demonstration of The Infra-Red Traffic Logger (TIRTL) system. This highly advanced traffic sensor can be used as a traffic counter, speed sensor, heavy vehicle tracker, and more, to help smooth traffic along I-680, while also supporting our Coordinated Adaptive Ramp Metering (CARM) strategy. #### **EXPRESS LANE COMPLETION**

We're looking forward to the release of the Draft Environmental Document (DED) for public review and input in mid-2024. The DED evaluates various alternatives for the express lane project. An alternative will be decided based on the feedback to begin the design phase. To stay up to date, check out our website.
